## Rationale for delivering the instruction in the courses and grades selected above \*

A monthly video schedule is published for all schools K-12.

The district will use the lessons and resources from iSafe to educate students about Internet safety. More information on iSafe can be found on page seven.

- 2. Each month, Internet safety information will be provided to students through public service announcements during morning announcements. The monthly videos are in addition to the required lessons conducted by ELA teachers and are not in the iSafe system. The videos are located on the school's file server and in Office Video. This year, three channels were added to Office Video to access the videos: MITD Internet Safety Elem, MITD Internet Safety Middle or MITD Internet Safety High. The complete video schedule can be found on page six.
- 3. The Media & Instructional Technology Department (MITD) will work with the District's webmaster to provide links to online Internet safety resources for parents and the community.
- 4. All schools are encouraged to participate in Digital Learning Day scheduled for February 27, 2020. Each school should develop activities to promote digital learning at their school. For more information on Digital Learning Day, go to www.digitallearningday.org.
- 5. The District has developed and deployed a desktop background to be standard for any computer designated as a "student computer" in Active Directory. The background will include Internet Safety Tips for students on the following topics: Cyberbullying Awareness and Response, Protecting Your Identity, Social Networking & Chat Rooms, E-mail, and Hacking. Illustrated below is a sample desktop adapted to meet current requirements of the E-rate Program.

#### **Child Trafficking**

- 1. In elementary, teachers, school counselors, social workers, and psychologists delivered lessons to each grade level.
- 2. In middle and high schools, the classroom teachers delivered lessons.
- 3. In all situations, teachers completed training in order to be able to follow the program expectations and guidelines. Counselors and administrators were always available for students who displayed any concerning behaviors.
